Six Sigma Quality International(SSQI), UKJAS & IAF-AB -certify associations can show their authorize status on client endorsements utilizing the Six Sigma Quality International(SSQI), UKJAS & IAF-AB certification **mark** (see supplement 1). Be that as it may, the association showing them will not deceive anybody; downgrade or debase the license mark; use them illicitly; or use them in opposition to the perceived license principles and related guides.

Laws of copyright cover the utilization and show of the imprint and logos, and the Six Sigma Quality International (SSQI), UKJAS & IAF-AB authorization mark and logos are the main variations associations authorize by Six Sigma Quality International (SSQI), UKJAS & IAF-AB are allowed to show.

Assuming you are an Six Sigma Quality International (SSQI), UKJAS & IAF-AB -licensed association

You might utilize the authorization **mark** (portrait or landscape version) on testaments and reports connecting with those exercises covered under your Six Sigma Quality International (SSQI), UKJAS & IAF-AB authorization. Any unaccredited outcomes or data in the testament or report should be obviously prohibited.

References to licensed status with the accreditation logos

Six Sigma Quality International (SSQI), UKJAS & IAF-AB -certify associations can likewise show certification **logos** intended for the authorization exercises (see Supplement 3) on the following:

- Citations and evaluations. These will demonstrate any exercises that are not Six Sigma Quality International (SSQI), UKJAS & IAF-AB certify.
- Corporate Writing material, e.g., letterheads, praise slips, solicitations
- Interior walls and entryways
- Show stands
- Websites - This is given the certification's extension and cutoff points are obviously portrayed. For example, accredited certification bodies might utilize the accreditation mark on all pages of their website gave they have a reasonable assertion/disclaimer close by the certification mark depicting the extension/limit of its license, i.e., "Our certification is restricted to those exercises depicted on our Six Sigma Quality International (SSQI), UKJAS & IAF-AB timetable of accreditation found here."

The Six Sigma Quality International (SSQI), UKJAS & IAF-AB certification mark or certification logo may not be utilized on:

- Vehicles
- Structures and Flags
- Merchandise or items except if these have been made under a licensed product conformity scheme.
- Essential bundling, e.g., rangle packs

Furthermore, on account of the accreditation mark for certification exercises, they may not be utilized on:

- Laboratories, Inspection Bodies, Proficiency Testing Providers, Reference Material Producers and Medical Diagnostic Service Providers issued reports and certificates.



Further Necessities

1. The license logos and any accreditation mark may simply be utilized to demonstrate an accredited status by the associations named on the Six Sigma Quality International (SSQI), UKJAS & IAF-AB license endorsement. Partner organizations of the accredited association may not show or reference the association's accredited status.
2. The license mark ought to be displayed on the client endorsement in a way that is the least dominant mark on it and in a style where it won't make any sensible individual deduce or in any case accept that the certificate or test report is given straight by Six Sigma Quality International (SSQI), UKJAS & IAF-AB.
3. The Six Sigma Quality International (SSQI), UKJAS & IAF-AB mark or logos may not be involved on an item or bundling in a way that suggests or could be deciphered as indicating product conformity.
4. The accredited association will stop utilizing certificates, mark, logos or alluding to its licensed status in the event that it is (i) not in great monetary remaining with Six Sigma Quality International (SSQI), UKJAS & IAF-AB and (ii) Assuming it has gotten a notification of progress of licensed status for withdrawal of accreditation certificate. The licensed association will make prompt arrangement for erasing references to accredited status and logos all stationary, advertisement, websites and different mediums.
5. Where important, a licensed association getting a notification of progress of certify status for withdrawal of accreditation certificate will educate those concerning its partners and other people who might have a sensible interest, like trading partners, clients and enrollment offices, that their licensed status has been removed.
6. The certify association will not make future arrangements (i.e., setting ads, ordering stationary, etc.) for the utilization of client certificates, logos or from alluding to its certify status assuming it is (i) not in great monetary remaining with Six Sigma Quality International (SSQI), UKJAS & IAF-AB and (ii) in the event that it has gotten a notification of progress of certify status for suspension of certificate.

9. Six Sigma Quality International (SSQI), UKJAS & IAF-AB -certify associations should guarantee that where their clients utilize the license logo, they consent to the right use. The authorization logo ought to be provided to clients as a joined logo with the Six Sigma Quality International (SSQI), UKJAS & IAF-AB -licensed associations on the left and the pertinent Six Sigma Quality International (SSQI), UKJAS & IAF-AB logo on the right (see model in supplement 4). The clients of the Six Sigma Quality International (SSQI), UKJAS & IAF-AB accredited associations should not utilize the accreditation mark.
10. Individual students of Six Sigma Quality International (SSQI), UKJAS & IAF-AB -certify training providers or licensed courses should not utilize the certification mark or logo.
